2. Scope of Services
The Company agrees to perform the following nuisance wildlife control services (the "Services") at the property listed above ("Service Address"):
• Initial Inspection: A thorough inspection to identify the target animal(s), entry points, and contributing factors.

5. Client Responsibilities

The Client agrees to:

- Provide the Company with access to parts of the property necessary to perform the services during agreed scheduled service times.
- Keep all pets, children, and non-authorized persons away from traps, trap monitoring cameras, and any other equipment used by the Company.
- Refrain from touching, moving, or tampering with any traps or equipment.
- Notify the Company immediately of any captured animals (target or non-target) or any

- disturbed equipment.
- Take reasonable steps to correct conditions conducive to the attraction of wildlife as recommended by the Company (e.g., securing trash, removing food sources).

6. Company Responsibilities & Animal Disposition

- The Company will perform all Services in a professional manner and in compliance with all applicable federal, state, and local wildlife and board of health laws and regulations.
- The Company will use humane and approved methods for all trapping and handling.
- **Animal Disposition:** The Company will handle all captured wildlife in accordance with state and local regulations. This may include, but is not limited to, on-site release (if permitted), relocation, or humane euthanasia. The Company will determine the appropriate and legal method.

7. Warranties & Limitations of Liability

- Exclusion Warranty: The Company provides a one year warranty on the craftsmanship of exclusion work performed, as detailed in Addendum A. This warranty is void if the repairs are altered, damaged by the Client, or compromised by new issues (e.g., rot, new construction). This warranty does not guarantee that no new animals will ever enter the property through a different area.
- **No Guarantee on Animal Behavior:** The Client understands that wildlife behavior is unpredictable. The Company does not guarantee that all target animals will be captured or that the property will be free of wildlife activity forever.
- **Non-Target Animals:** The Company is not responsible for the capture of non-target animals (e.g., domestic pets). The Client is solely responsible for keeping all pets secured and away from service areas.
- **Indemnification:** The Client agrees to indemnify and hold harmless the Company from any and all claims, damages, or liabilities arising from the Client's failure to adhere to their responsibilities under this Contract, including injury to persons or pets who tamper with equipment.

8. Contract Termination

This Contract may be terminated by either party written notice. If the Client terminates the Contract before Services are complete, the Client agrees to pay for all Services performed and costs incurred up to the date of termination.

9. Entire Agreement

This document and any attached Addendums represent the entire agreement between the Company and the Client. No other statements, promises, or representations will be binding. This Contract may only be modified in writing and signed by both parties.
